B. Board Policy/Academic Policy - 4235 Credit By Examination

The committee reviewed and discussed Taft College's "Credit by Exam" (AP/BP 4235) policy. Spanish courses were identified among the most popular exams. V. Jacobi shared revision ideas with the group. Possible revisions include dropping the Grade Point Average requirement from 2.5 to 2.0. Divisions and Counselors were asked to review and discuss possible changes to the policy. This item will be voted on at our next C & GE meeting in May 2020.
