The following items were pulled from the consent agenda: PSYC 2033, READ 1005, and ENGL 1501. On a motion by M. Oja, seconded by J. Rangel-Escobedo and unanimously carried by all the remaining consent items were approved. M. Oja asked that changed be made to the pass/no pass and credit by exam areas of PSYC 2033. On a motion by M. Mayfield, J. Martinez seconded, and unanimously carried by all PSYC 2033 was approved with changes to pass/no pass and credit by exam. K. Carlson requested that the SLO for READ 1005 remain as originally submitted. On a motion by M. Oja, seconded by J. Martinez, and unanimously carried by all READ 1005 was approved with the original SLOs. On a motion by K. Carlson, seconded by M. Oja and unanimously carried, ENGL 1501 was tabled while the division creates a reading list for the COR.

IV. Program Revision:

Program Revisions

Disability Services – Associate in Science

On a motion by J. Rangel-Escobedo, seconded by M. Oja, and unanimously carried by all, the program revision to Disability Services was approved.

V. Distance Learning:

1. SPCH 1511 Public Speaking

A. Bledsoe clarified that the request is to make SPCH 1511 a hybrid course. Its approval for online/offline will be removed. On a motion by J. Martinez, seconded by J. Chaidez, and unanimously carried, the approval of SPCH 1511 as a hybrid was approved.

IV. INFORMATIONAL ITEM:

A. Distance Learning Application Process

M. Oja asked if a COR update has to wait for the Distance Learning Application approval in order to move forward to the Curriculum committee. It was explained that it would be very difficult administratively to track if these forms were to go to separate meetings. Also, if there is a delay for a

B. Work Experience – COR –

There are several Work Experience courses offered in specific disciplines such as welding and energy technology. Divisions were asked to review these CORs and think about the possibility of expanding offerings.

C. INCO 1048

J. Chaidez presented possible revisions of INCO 1048 on the behalf of Terri Smith. T. Smith will be making changes to the COR and wanted feedback from the larger Curriculum committee. Some of the changes include changing to the prefix and title, making the course transferable (again), adding an advisory of being eligible for ENGL 1500. Discussion was had about requiring transfer students to take the course. That isn't possible as it doesn't meet the CSU-GE transfer pattern or the IGETC and ADTs are prescribed degrees. Once T. Smith makes changes to the COR, this will be submitted through Curriculum.
