Re: Lost Hills Water District: Written Offer to Sell Property (Gov. Code, § 54222)

Gentlepersons:

We are counsel for Lost Hills Water District (**District**) and write this letter on its behalf.

The District is a California water district organized under Division 13 of the Water Code. The District is a "local agency" for the purposes of Government Code section 54222. The District holds interests in certain "land" within its boundaries as a result of the non-payment of District assessments and the recording of collector's deeds. I Enclosed is a list of the lands (**Listed Lands**) in which the District has an interest. The District plans to sell its interest in many of the Listed Lands in the near future.

Government Code section 54222 requires the District to make a written offer to sell the Listed Lands to the persons identified therein if, for example, the Listed Lands could be used for low-and moderate-income housing purposes, park and recreational or open space purposes, or school facilities construction or school district open-space purposes. Insofar as we

are aware, the Listed Lands are not suited for any of the foregoing purposes since most of the lands within the District are used or useful for agricultural purposes.

If you have any desire to purchase any of the Listed Lands for any of the purposes enumerated in Government Code section 54222, please notify the District of your intent to purchase such land within 60 days after receipt of this letter. Your notice should be addressed to the District at 1405 Commercial Way, Ste. 125, Bakersfield, CA 93309. Please provide us with a courtesy copy of your notice.
