<u>Criminal Justice Administration (CJA) 1057 Arrest and Control Techniques PC 832 (2.5 units)</u> [Formerly Criminal Justice Administration 57ABCD]

Prerequisite: None

Total Hours: 40 hours lecture

Catalog Description: This course introduces methods and regulations used by peace officers regarding the powers of arrest, search and seizure. Students will engage in the use of weaponless self-defense and physical arrest activities. The course is designed to meet the requirements of California Penal Code Section 832, which establishes a minimum mandatory standard of training for Peace Officers in the State of California. This course meets the Commission on Peace Officers Standards and Training (POST) requirements. This course includes strenuous physical activity. This course is offered on a pass/no pass basis only. This course is repeatable. Only 2.5 units can be applied towards an Associate degree.

Learning Activities Required Outside of Class:

The students in this class will spend a minimum of 5 hours per week outside of the regular class time doing the following:

- 1. Completion of assigned reading.
- 2. Students will prepare a written summary of the skills learned.
- 3. Practicing and enhancing physical skills related to defensive tactics.

Methods of Instruction:

- 1. Lecture
- 2. Demonstration
- 3. Class Discussions and Participation
- 4. Audiovisual Presentations and Practical Exercises
- 5. Exercises in small groups and one-on-one instruction as needed
 - a. Verbal commands
 - b. Restraint/control hold techniques
 - c. Takedown techniques
 - d. Searches from the standing, kneeling and prone positions
 - e. Handcuffing techniques from the standing, kneeling and prone positions
 - f. Custody handcuffing vs. field handcuffing

Methods of Evaluation

- 1. Students are required to pass a written test produced by POST
- 2. Students are required to perform a physical activity exam which includes:
 - a. demonstration of footwork
 - b. conducting a clothed search of a person
 - c. demonstrating a control hold, take-down, and proper handcuffing techniques
