Catalog Description: This course focuses on increasing awareness of rights and responsibilities of adults. An historical overview of societal perspectives of persons with disabilities, the civil rights era, and key legislation are included. Requirements of Individual Program Plan (IPP) will be examined, and how to prepare for an IPP meeting will be learned.
