The Office is responsible for anticipating the student services programs needed to meet the educational needs of students and the community college district at large, and ensuring excellence in both ongoing and developing student affairs programs and services. The Office also leads the development and prioritization of budget recommendations from all student services areas, and assists in the preparation and administration of the annual budget. Finally, the Vice President of Student Services currently serves as the Chair of Campus Safety and Security and the Public Information Officer. He also co-chairs the Access

The outstanding academic performance of Athletes exemplifies 15-to- finish cohorts leading to completion within two to three years of study.

The increased awareness of campus safety and security and availability of security personnel on campus created an atmosphere conducive for learning. Campus safety and security aids/guides are also available at the college website.
