# Governance Council—April 17 2015 Proposed Revised Institution-Set Standards

The Strategic Planning Committee recommends Taft College adopt four Institution-Set Standards, described below. Three are "leading indicators" that can be acted upon and the fourth is a "lagging indicator" required by the ACCJC Annual Report that will be affected by the three leading indicators. The SPC recommends that these metrics and the values shown below be accepted and used by Taft College to improve student success on all of the Scorecard indicators.

Each metric below would be disaggregated on a set of appropriate variables, low performing subpopulations would be indentified using the "80% rule," and appropriate interventions developed and implemented. After one year, the results would be evaluated and the cycle would continue.
