Dear President Maloney:

Taft College staff has brought to the attention of ACCJC that the College will be offering six new degrees. The information provided by the College indicates these degrees to not contain new courses or substantial changes, but instead reformats existing curriculum. This curriculum change is in response to the Student Transfer Reform Act, also known as California State Senate Bill 1440, which mandates that California Community Colleges (CCC) develop transfer degrees to facilitate the successful transfer of students from the CCC system to the California State University system.

The new transfer degrees are:

- Art History AA-T
- Early Childhood Education AA-T
- History AA-T
- Psychology AA-T
- Sociology AA-T
- Studio Arts AA-T

In addition, College staff reported several programs representing repackaged curriculum and new names:

- Administrative Services, formerly Secretarial Studies
- Energy Technology, formerly Petroleum Technology
- Information Management and Technology, formerly Information Management
- Welding Courses, now a Welding Program

Three program areas replaced by the updated curriculum repackaging are 1) Computer Science, 2) Industrial Technology, and 3) Office Technology.

Based on the information provided by College staff, the aforementioned changes do not require a substantive change review by the Commission.
